PSST and Cyren Call End Advisory Relationship

McLean, Va. and Washington, D.C. – March 6, 2009 – Today, Cyren Call Communications Corporation announced that it has informed the Public Safety Spectrum Trust Corporation (PSST) that Cyren Call will no longer serve as the advisor to the PSST and the related contract between the parties is being terminated. Various factors – the lack of an adequate source of funding to support substantial ongoing activities on behalf of the PSST, the indefinite hiatus in the regulatory processes toward creation of a nationwide network for public safety, the recalibration affecting both personnel and policy that naturally follows the change in administration and the continuing turmoil in the financial markets - led the parties to conclude their formal relationship.

Morgan O'Brien, Chairman of Cyren Call, said, "There is a new environment taking shape and a new team is being assembled in Washington, DC. As a result, those of us pursuing the creation of a nationwide network for public safety, along with many who are following other wireless communications initiatives, will need patience as the dust settles and priorities begin to take shape. In addition, the broadband communications provisions in the American Recovery and Reinvestment Act seem to suggest an expanded role for state and local governments around the country, many of whom have long grappled with the problems caused by the lack of public safety communications interoperability. This, hopefully along with the extensive record compiled by the Federal Communications Commission (FCC), will be integrated into and will influence the thinking of the FCC. I have every confidence the process of finding a suitable mobile broadband communications solution for public safety again will receive the urgent and sustained attention it deserves with new people in place at the FCC and in Congress under the leadership of Chairmen Rockefeller and Inouye in the Senate and Chairmen Waxman, Boucher and Obey in the House of Representatives. But as we stand here today, there is no way of knowing when or along what path the process will move forward. It is realities and considerations like these that have led us to the decision we've announced today."

Mr. O'Brien added, "Under incredibly difficult circumstances, with no source of funding and with the best interest of public safety guiding his every step, PSST Chairman Chief Harlin McEwen has worked tirelessly to solve public safety's communications crisis. We have proudly stood by his side in our formal role as advisor to the PSST. His indefatigable efforts are the cornerstone of the significant progress achieved to date. His colleagues on the PSST who have provided consistent and unwavering support and appreciation for his efforts, particularly those on the PSST Executive Committee, Kevin McGinnis and Alan Caldwell, deserve recognition for their inspired contributions to the cause of improving public safety communications and enabling nationwide interoperable communications. Backed by the considerable knowledge, experience and influence of the member organizations represented on the PSST's Board, and holding a nationwide broadband spectrum license of incalculable value, the PSST stands poised to play a pivotal role as government crafts a solution to this long-standing crisis."

Chief Harlin R. McEwen, Chairman of the PSST, said, "I have truly enjoyed working with Morgan O'Brien and the team at Cyren Call. The talents that Cyren Call has brought to bear, and the spirit of innovation, initiative and determination they have brought to their work for the PSST, have been of enormous assistance to the PSST. Combined with the drive and dedication of the many PSST member organizations, Cyren Call's efforts



have brought about groundbreaking outcomes that position us well for continuing the task of delivering broadband wireless communications capabilities that first responders urgently require in their mission-critical work. As much as the PSST has benefitted from Cyren Call's services as advisor, the significant unknowns suggest that we and Cyren Call now should end our formal advisory relationship. I would have preferred to have the resources in hand so that we and Cyren Call could have maintained our relationship, but I hasten to add that I believe the PSST will endure and will continue to strive onward toward the ultimate goal – bringing broadband wireless communications capabilities to the public safety community. Recent concerns raised by some of the larger cities make it critical that the PSST reach out to determine how we should proceed in the future.”

This statement is intended to serve as notification to all interested parties that Cyren Call is no longer the advisor to, nor an appropriate contact point for, the PSST.
