The **National Interoperability Information eXchange (NIIX)** is a free online tool available to public safety for storing, sharing, and reviewing documents. This secure central warehouse is efficient and easy to use with online and telephone support readily available to answer any questions you may have. As a member of NIIX, your public safety communications and interoperability project collaboration will rise to a new level!

NIIX is...

- A free website service to the public safety communications community.
- A centralized, secure warehouse to store and share National Repository and Community documents, and
- A website with tools to allow easy collaboration, communication, and sharing of information within Communities.

Originally developed to assist government agencies as they developed their Statewide Communications Interoperability Plans (SCIPs) for interoperability, NIIX is not limited to statewide planning, but can be used to serve federal, state, and local public safety users who need a collaborative tool.
